K.Dasan, MLA representing Quilandy Constituency** as per the letter read as 2<sup>nd</sup> paper above, the Chief Engineer, PWD(R&B) Thiruvananthapuram has forwarded detailed estimate of the work **'Improvements to NH Sreekurumba Bhagavathi Temple Road from Km 0/000 to 0/300 in Payyoli Grama Panchayat'** under LAC-ADS for the year 2014-15 at an estimate cost of **Rs.15,00,000/-(Rupees Fifteen Lac only)** as per the reference read as 3<sup>rd</sup> paper above to accord Administrative Sanction and Special Sanction. Payyoli Grama Panchayat passed and forwarded resolution in this regard as per the reference read as 4<sup>th</sup> paper above.
