ORDER

Smt.Padmaja.M , W/o.late. Rajeevan.C.H, who died in harness on 18/05/2013 while working as Part Time Road Sweeper in Pallikkara Grama Panchayat ,Kasaragode District applied for employment assistance under Compassionate Employment Scheme. The deceased Government servant put in a total service of 4 years 4 months and 23 days.

The applicant is 35 years old as her date of birth being 22/5/1980. She has passed SSLC examination. The request is for the appointment in the post of Lower Division Clerk and she is qualified for that post.

The Director of Panchayats and the District Collector, Kasaragode as per the letters read as 3rd and 4th papers above have recommended the request of Smt.Padmaja.M. All the legal heirs of the deceased have also relinquished their claims in favour of the applicant and have given their consent statements. The applicant is a real dependent of the deceased. None of the dependents of the deceased has applied for availing the benefit under the scheme earlier. No other family members of the applicant have got appointment under the Scheme.

The District Collector, Kasaragode as per the letter read as 4th paper above has reported that the annual family income of the deceased Government Servant is Rs.32,208/- (Rupees Thirty Two Thousand Two Hundred and Eight only).

In the above circumstances, sanction is accorded to the Deputy Director of Panchayats, Kasaragode to appoint Smt.Padmaja.M, W/o. late. Rajeevan C.H, Part Time Road Sweeper, Pallikkara Grama Panchayat, Kasaragode District in the existing/arising vacancy of Lower Division Clerk in Kasaragode District under Compassionate Employment Scheme, subject to the conditions laid down in the Government Order read as 1st paper above after verifying all the original certificates.

The Deputy Director of Panchayats, Kasaragode shall make necessary entries in the Service Book of the deceased Government employee and in the Establishment Register, regarding grant of employment to the dependent as stipulated in the Government Order read as 1st paper above.

The employment assistance under the scheme will be cancelled if and when it is found that there is any misrepresentation or suppression of material facts on the part of the incumbent during the course of enquiry conducted by various Government agencies.
