### ORDER

As per the letter read as 1<sup>st</sup> paper Ministry of Rural Development issued broad guidelines for the preparation of the Perspective Development Plan for phase II & III districts under Mahatma Gandhi NREGA. The guidelines stipulates that the District can seek assistance to an expert agency to prepare/develop the perspective plan. Accordingly, the Search Committee constituted by the State Employment Guarantee Council had identified and selected various expert agencies for providing professional assistance for the said purpose. Based on the recommendations of the Committee Government have accorded sanction to engage them for the preparation of District Perspective Plan, vide order read as 2<sup>nd</sup> paper. The Central assistance for an amount of Rs.10 lakhs had been made available for the preparation of Perspective Plan and an amount of Rs.40 lakhs for printing and processing statutory documents creation of infrastructure and computational facilities etc. to each of the phase I & II districts including Alappuzha during 2007-08. The Perspective plans prepared by the agencies had been approved and the Joint Programme Co-ordinators of the Districts were permitted to release the third and final instalment of Rs.2 lakhs to the agencies.

2. The Mission Director, Mahatma Gandhi National Rural Employment Guarantee Scheme as per the letter cited as 3<sup>rd</sup> paper has informed that an amount of eight lakh was released to Centre for Socio Economic Studies, Kochi, which was entrusted for the preparation of the District Perspective Plan of the District and an amount of Rs.2 lakhs is due towards last instalment. However, the balance in the

account maintained for the purpose of payment of Perspective Plan preparation charges is nil. The amount of Rs.2 lakhs was already expended to meet Administrative Expenditure of the Joint Programme Co-ordinator's Office and was not recouped at that time from Administrative cost. Therefore, the Mission Director has requested that the diversion, by the Joint Programme Co-ordinator, Alappuzha, of an amount Rs.2 lakhs, meant for meeting the charges of Perspective Plan preparation, to meet the administrative cost of the Joint Programme Co-ordinator's office should be ratified with a permission to recoup the said amount from the administrative cost of Mahatma Gandhi National Rural Employment Guarantee Scheme for the year 2015-2016.

3. Government have examined the matter in detail and are pleased to ratify the diversion, by the Joint Programme Co-ordinator, Alappuzha, of an amount of Rs.2 lakhs, meant for meeting the charges of Perspective Plan preparation, to meet the administrative cost of the Joint Programme Co-ordinator's office, with a permission to recoup the said amount from the administrative cost of Mahatma Gandhi NREGS for the year 2015-2016.
