**ORDER**

Smt. Sini Maniyath, D/o.late. K.Nanu, Part time Pound Keeper, who died on 25/7/2012 while working as Part time Pound Keeper, Keezhoor Chavassery Grama Panchayat, Kannur District, applied for employment assistance under Compassionate Employment Scheme. The deceased Government servant put in a total service of 17 years 2 months and 6 days.

The applicant is 37 years old, as her date of birth being 8/03/1978. She has passed SSLC examination. The request is for appointment to the post of Lower Division Clerk in Kannur District and she is qualified for that post.

The Director of Panchayats and the District Collector, Kannur as per the letters read as 5<sup>th</sup> and 6<sup>th</sup> papers above have recommended the request of Smt. Sini Maniyath. All the legal heirs of the deceased have relinquished their claims in favour of the applicant and have given their consent statements . The applicant is a real dependent of the deceased. None of the dependents of the deceased has applied for availing the benefit under the scheme earlier. No other family members of the applicant have got appointment under the Scheme.

The District Collector, Kannur as per the letter read as 6<sup>th</sup> paper above has reported that the annual family income of the deceased government servant is Rs.24,000/- (Rupees Twenty four thousand only).

In the above circumstances, sanction is accorded to the Director of Panchayats, Thiruvananthapuram to appoint Smt. Sini Maniyath, Nellolikandy House, Kottam P.O, Mundalooore -670 622, Kannur in the existing/arising vacancy of Lower Division Clerk in Kannur District under Compassionate Employment Scheme, subject to the conditions laid down in the Government Order read as 1<sup>st</sup> and 2<sup>nd</sup> papers above after verifying the original certificates to prove age, educational qualification, medical fitness etc.

The Director of Panchayats, Thiruvananthapuram shall make necessary entries in the Service Book of the deceased Government employee and in the Establishment Register, regarding grant of employment to the dependent as stipulated in the Government Order read as 1<sup>st</sup> paper above.

The employment assistance under the scheme will be cancelled if and when it is found that there is any misrepresentation or suppression of material facts on the part of the incumbent at the time of submission of the application or during the course of enquiry conducted by various Government agencies.
