ORDER

Smt. Sumithra.C W/o.late. M.K.Gangadharan, who died in harness on 14/02/2013 while working as Lower Division Clerk, Nenmeni Grama Panchayat, Wayanad District applied for employment assistance under Compassionate Employment Scheme. The deceased Government servant put in a total service of 15 years 2 months and 14 days.

The applicant is 38 years old as her date of birth being 29/05/1977. She has passed SSLC Examination. The request is for appointment to the post of Lower Division Clerk and she is qualified for that post.

The Director of Panchayats and the District Collector, Wayanad as per the letters read as 4th and 5th papers above have recommended the request of Smt. Sumithra.C. All the legal heirs of the deceased have also relinquished their claims in favour of the applicant and have given their consent statements. The applicant is a real dependent of the deceased. None of the dependents of the deceased has applied for availing the benefit under the scheme earlier. No other family members of the applicant have got appointment under the Scheme earlier.

The District Collector, Wayanad as per letter read as 5th paper above has reported that the annual family income of the deceased Government Servant is Rs.2,25,828/- (Rupees Two lakhs Twenty five thousand Eight hundred and twenty eight only).

In the above circumstances, sanction is accorded to the Director of Panchayats, Thiruvananthapuram to appoint Smt. Sumithra.C W/o.late. M.K.Gangadharan, Madoor Kuruma Colony Vakery P.O,Sulthan Bethery,Wayanad in the existing/arising vacancy of Lower Division Clerk in Wayanad District under Compassionate Employment Scheme, subject to the conditions laid down in the Government Order read as 1st paper above after verifying all the original certificates to prove age, educational qualification, medical fitness etc and also subject to the other conditions under the scheme in force.

The Deputy Director of Panchayats, Wayanad shall make necessary entries in the Service Book of the deceased Government employee and in the Establishment Register, regarding grant of employment to the dependent as stipulated in the Government Order read as 1st paper above.

The employment assistance under the scheme will be cancelled if and when it is found that there is any misrepresentation or suppression of material facts on the part of the incumbent at the time of the submission of the application or during the course of enquiry conducted by various Government agencies.
