ORDER

Shri.Jinshad Hassan, S/o.late Ali Hassan, former Village Extension Officer, Block Panchayath, Bharanikkavu, Alappuzha District residing at Nassahilam, Athikkattukulangara.P.O, Nooranad; Alappuzha, as per his application read as 2nd paper above has applied for employment assistance under Compassionate Employment Scheme. The matter was enquired through the District Collector, Alappuzha and has recommended the request for employment assistance as per the report read as 4th paper above.

Sri.Ali Hassan expired on 12.9.2013, while working as Village Extension Officer in Block Development Office, Bharanikkavu, Alappuzha District, Rural Development Department. He had put in a total service of 23 years at the time of his death. His Son Sri.Jinshad Hassan has applied for employment assistance under the scheme. All other dependents have relinquished their claim for employment assistance in favour of the applicant.

Sri.Jinshad Hassan has passed Higher Secondary Examination. He is aged 21 years. His date of birth is 14.9.1994. He has requested for appointment as Village Extension Officer/L.D.Clerk in Rural Development Department in Alappuzha District. The applicant satisfies all the conditions for being appointed as Village Extension Officer.

In the circumstances reported by the Commissioner for Rural Development, Thiruvananthapuram and the District Collector, Alappuzha in their letters read as 3rd and 4th papers above and as per the provisions contained in the Government Order read as 1st paper above, sanction is accorded for the

appointment of Shri.Jinshad Hassan, S/o.late Ali Hassan, former Village Extension Officer, Block Panchayath, Bharanikkavu, Alappuzha District residing at Nassahilam, Athikkattukulangara.P.O, Nooranad, Alappuzha in the existing/ arising vacancy of Village Extension Officer in the Rural Development Department in Alappuzha District subject to the provisions governing the scheme. The Commissioner for Rural Development will issue formal posting orders to the applicant. Sri.Jinshad Hassan will produce a copy of his photograph, recently taken, duly attested by a Gazetted Officer before the Commissioner for Rural Development at the time of joining duty. Before admitting him to duty, the original documents in proof of his age, educational qualification and medical fitness should be verified. His character and antecedents will also be got verified through the Police Department in due course. If the appointment is in a District other than the District of option for want of vacancy, he will be given transfer to the District of option in the next arising vacancy without loss of seniority. The five year rule prescribed for inter-district transfer of district-wise recruits will be made applicable in this case from the date of posting to the district of his choice. The details of appointment under the scheme will be entered in the Service Book of the deceased Government employee and also in the Establishment Register of the office in which the Government employee last worked and the fact will be attested by Head of office/Head of Department.

The appointment will be cancelled if and when it is found that there was misrepresentation or suppression of material facts at the time of applying for appointment under the Compassionate Employment Scheme or during the course of the enquiry by the departmental authorities.

Government will have the right to cancel the order sanctioning this appointment under the Compassionate Employment Scheme if, after the issue of the order, it is seen on examination that the orders were issued erroneously.
