Sericulture activity in the State was undertaken by Kerala State Sericulture Co-operative Federation Limited (SERIFED). Following the liquidation of SERIFED in 2010, sericulture activity in the state was undertaken by Rural Development Department. As per the Government Order read as 2nd paper above, Government had approved the guideline for the implementation of the scheme in the State. Member Secretary, Central Silk board as per the letter read as 3rd paper above have informed the releasing of Rs.35,00,000/- (Rupees Thirty Five Lakhs only) to Commissioner for Rural Development as Central Share for the financial year 2015-16 for sericulture development activity in the state. The Commissioner for Rural Development as per the letter read as 4th paper above, submitted a comprehensive proposal for Rs.44.55 Lakhs for the financial year 2015-16 for the implementation of Sericulture Development Project in the State.

2) Government have examined the matter in detail and are pleased to accord Administrative Sanction for implementation of Sericulture Development Project for Rs.79.55 Lakhs (Seventy Nine Lakhs Fifty five Thousand only)(Central Share – Rupees Thirty Five Lakhs + State Share forty four Lakhs fifty five thousand only) for Sericulture

Activity in the State for the financial year 2015-16.
