ORDER

Smt. Reeja D., W/o Late VijayaKumar M., who died in harness on 21/05/2014 while working as Office Attendant, LSGD Sub Division, Chittumala Block Panchayat, Kollam District, has applied for employment assistance under the Compassionate Employment Scheme as per the application read as 2nd paper above. The application was submitted within the prescribed time limit. The deceased Government servant put in a total service of 8 Years and 10 Months.

2. The applicant is 40 years old as her date of birth is 02/04/1976. She has passed SSLC examination, and Pre Degree.. The request is for appointment in the post of Clerk and she is qualified for that post.

3. The Chief Engineer, LSGD, Thiruvananthapuram and the District Collector, Kollam as per the letters read as 3rd and 4th papers above have recommended the request of Smt. Reeja D.. All the legal heirs of the deceased have relinquished their claims in favour of the applicant and have given their consent statements. The applicant is the wife of the deceased. None of the dependants of the deceased has applied for availing the benefit under the scheme earlier. No other family members of the applicant have got appointment under the Scheme.

4. The District Collector, Kollam as per the letter read as 4th paper above has reported that the annual family income of the deceased Government Servant is Rs.

1,94,520/- (One lakh ninety four thousand five hundred and twenty rupees only).

5. In the circumstances, Government are pleased to accord sanction for the appointment of Smt. Reeja D., W/o Late: VijayaKumar M., as Clerk in the Local Self Government (Engineering Wing) Department in Kollam District in the existing or next arising vacancy under the Compassionate Employment Scheme, subject to the conditions laid down in the Government Order read as 1st paper above. Necessary entries in this regard will be made in the Service Book of the deceased Government servant and also in the Establishment Register of the office where the deceased employee last worked and the entries will be attested by the Head of Office/Head of Department.

6. The employment assistance ordered under the scheme will be cancelled if and when Government find that there was any suppression or misrepresentation of material facts on the part of the applicant at the time of forwarding the application or during the course of inquiry conducted by the Department in which she is appointed.

7. The Chief Engineer, Local Self Government Department, Thiruvananthapuram will issue necessary posting orders to Smt. Reeja D. after verification of the original documents produced by her to prove age, educational qualification, medical fitness and after confirming the genuineness of the same and also subject to other conditions under the scheme in force.
