ORDER

As per the Government Order read as first paper above Government have accorded detailed administrative sanction and working instruction for Swachh Bharat Mission (Urban).

Vide Office Memorandum read as third paper above the Ministry of Urban Development, Government of India has revised / modified the operational guidelines of Swachh Bharat Mission (Urban).

In the letter read as second paper above the Executive Director, Suchitwa Mission has requested to issue a Government Order with the following changes in partial modification of the G.O. read as first paper above:

1. Redetermining targets, under Individual Household Toilets, Community Toilets

The State High Power Committee shall have the flexibility to redetermine targets for Individual Household Toilets (IHHL) and Community Toilets (CTs), subject to overall State/ULB wise funds envelope (sum of allocation under IHHL and CTs for the entire mission period) remaining unchanged.

2. Individual Household Toilet (IHHL)

There will be no change in the unit cost of IHHL (Rs,15.400/-). The Central and State Share shall be in the ratio 60:40 for IHHL component. Hence the revised share among Centre, State and ULB shall be Central Share Rs.4000, State Share Rs.2667 and ULB share Rs.8733/-, per IHHL.

3. Community Toilet

Unit cost of Community Toilet is enhanced to Rs.98,000/- per seat. Wherein VGF/Grant will be up to 40% of project cost (i.e. VGF/Grant of Rs.39,200/- per seat). State will contribute Rs.26,133/- (40% fund towards Community Toilet project to match 60% Central Share). Urban local bodies shall contribute Rs.32,667/- for the construction. This will be subject to overall State/ULB fund envelope (sum of allocation under IHHL and Community Toilets for the entire mission period) remaining unchanged. This marks a shift from monitoring of toilet construction to monitoring of ODF status achievement.

4. Public Toilet

Extension of VGF/Grant of up to 40% as available for Community Toilets (CT) to Public Toilets (PT) project as well [Unit cost of Public Toilets will be same as the Community Toilets]. The funding pattern for Public Toilet is same as Community Toilet. i.e. Central Share: Rs.39,200/-, State Share: Rs.26,133/- and UEB Share: Rs.32,667/-. Target for the Public Toilet to be set under Community Toilet components. This will be subject to overall State/ULB wise funds envelope (sum of allocation under IHHL and the Community Toilets for the entire mission period) remaining unchanged.

5. Urinals

Urinals are included in ODF components, wherein VGF/Grant of up to 40% to be given on lines of Community Toilets / Public Toilets, and base cost of urinals to be Rs.32,000 per unit (ie. VGF/Grant of Rs.12,800 per unit). State will contribute Rs.8533/- (40% fund towards urinal project to match 60% Central Share). Urban local bodies shall contribute Rs. 10,667/- for the construction. Targets for urinals to be set under Community Toilets components. This will subject to overall State/ULB wise fund envelope (sum of allocation under IHHL and Community Toilets for the entire mission period) remaining unchanged.

6. Solid Waste Management (SWM)

The Central assistance for Municipal Solid Waste Management component is raised from present 20% to 35%. Hence Central Government incentive fixed for Solid Waste Management projects will be in the form of maximum 35% Grant/VGF for each project. State shall contribute 40% of funds to match 60% Central Share. Balance fund shall be met by concerned ULBs. This will be subject to overall State/ULB wise funds envelope, for the entire mission period, for Solid Waste Management remaining unchanged.

7. IEC and Public Awareness, Capacity Building and Administrative and Office Expenses.

State will contribute 40% funds to match 60% Central Share for these components.

Government have examined the matter and are pleased to modify the Government Order read as first paper above with the changes mentioned above.
