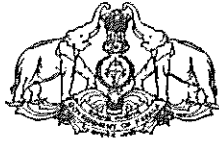

ORDER

As per the letter read as 1st paper above, the Secretary, State Delimitation Commission has requested to accord sanction for one month's basic pay as honorarium to the Chairman, Members, Secretary and other staff of the State Delimitation Commission for the meritorious work performed by them during the delimitation process in connection with General Elections to Local Self Government Institutions, 2015.

As per letter read as 2nd paper above, the Secretary, State Election Commission has informed that the total financial commitment involved in the proposal for the payment of honorarium will be Rs.5,60,375/- (Rupees Five lakh sixty thousand three hundred seventy five only) and it can be met from the Head of Account "2015-109-99-34-Other Charges" in respect of the State Election Commission.
