ORDER

Government in its order read as 1st paper above have sanctioned the Implementation of Home Delivery of Social Security Pensions through District Co-operative Banks (DCB)/Primary Agricultural Credit Societies (PACS) and Other Credit Co Operatives. The Social security Pension for the month of October, November and December 2016 has been sanctioned vide Government Order read as 4th paper above. The direct to home disbursement for the Month of October, November and December 2016 has been implemented successfully through the PACS/OCC.

2. Considering the extensive and time bound work, Government have sanctioned the incentive to the Primary Agricultural Credit Societies (PACS) and Other Credit Co-operatives (OCC) @ Rs 50/- per pensioner vide order cited as 5th paper above.

3. The Government after having examined the matter in detail and are pleased to sanction an amount of ₹ 59067700/- (Rupees Five crore Ninety lakhs Sixty Seven Thousand

Seven Hundred only) as 75% of the total incentive to the Primary Agricultural Credit Societies (PACS) and Other Credit Co Operatives engaged for the implementation of Home delivery of Social Security Pension for the Month of October, November and December 2016. The district wise incentive details and head of accounts are annexed with this order. The remaining incentive will be sanctioned after settling the account of the distribution of pension.

4. DBT Cell in the Directorate of Panchayats is authorized to draw the amount and transfer credit the same to the accounts of the Joint Registrars of the Co-operative Societies and in turn to the accounts of the PACS/OCCS.
