ORDER

Kum. Sreelekha C.D, D/o late Dinesh C.V, former Secretary, Thiruvilwamala Grama Panchayat, Thrissur District has applied for employment assistance under the Compassionate Employment Scheme in Thrissur District. The deceased Government servant had put in a total service of 21 years 8 months and 3 days.

The applicant is 21 years of age as her date of birth is 22.08.1995. She has passed the Plus two course. The Director of Panchayats and the District Collector, Thrissur as per the letters read as 4th and 5th paper respectively recommended the application of Kum. Sreelekha C.D. All the legal heirs of the deceased have also relinquished their claims in favour of the applicant and have given consent statements. The applicant is a real dependent of the deceased. None of the dependents of the deceased has applied for availing the benefit under the scheme earlier. No other family members of the applicant has got appointment under the scheme.

The District Collector, Thrissur as per the letter read as 5th paper above has reported that the annual family income of the deceased Government servant is Rs.5,08,500/- (Rupees five lakh eight thousand five hundred only).

In the above circumstances sanction is accorded to the Director of Panchayats, to appoint Kum. Sreelekha C.D, D/o late Dinesh C.V, former Secretary, Thiruvilwamala Grama Panchayat, Thrissur District in the existing/arising vacancy of the Lower Division Clerk in Thrissur District under the Compassionate Employment Scheme subject to the conditions laid down in the Government Orders read as 1st and 2nd paper above, after verifying all the original certificates.

Necessary entries shall be made in the Service Book of the deceased employee and in the Establishment Register regarding the grant of employment to the dependent as stipulated in the Government Order read as 1st paper above.

The employment assistance under the scheme will be cancelled if and when it is found that there is any misrepresentation or suppression of material facts on the part of the incumbent in the course of enquiry conducted by various Government agencies.
