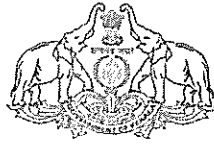

ORDER

Sri.Davis Richard, S/o Late Richard D., who died in harness on 31/08/2013 while working as Overseer Grade I, Kunnamkulam Municipality, has applied for employment assistance under the Compassionate Employment Scheme as per the application read as 2nd paper above. The application was submitted within the prescribed time limit. The deceased Government servant put in a total service of 22 years 6 Months and 5 days.

2. The applicant is 19 years old as his date of birth is 12/07/1997. He has passed Higher Secondary Examination. The request is for appointment in the post of Clerk and he is qualified for that post.

3. The Chief Engineer, LSGD, Thiruvananthapuram and the District Collector, Thrissur as per the letters read as 3rd and 4th papers above have recommended the request of Sri.Davis Richard. Sri.Devassia Richard, the only other legal heir to late Richard D., has relinquished his claim in favour of the applicant and has given his consent statement. The applicant is the son of the deceased. The annual family income of the deceased Government Servant is ₹ 3,88,944/- (Rupees Three lakh eighty eight thousand nine hundred and forty four only).

4. In the circumstances, Government are pleased to accord sanction for the appointment of Sri.Davis Richard, S/o Late Richard D., as Clerk in the Local Self Government (Engineering Wing) Department in Thrissur District in the existing or next arising vacancy under the Compassionate Employment Scheme, subject to the conditions laid down in the Government Order read as 1st paper above. Necessary entries in this regard will be made in the Service Book of the deceased Government servant and also in the Establishment Register of the office where the deceased employee last worked and the entries will be attested by the Head of Office/Head of Department.

5. The employment assistance ordered under the scheme will be cancelled if and when Government find that there was any suppression or misrepresentation of material facts on the part of the applicant at the time of forwarding the application or during the course of inquiry conducted by the Department in which he is appointed.

6. The Chief Engineer, Local Self Government Department, Thiruvananthapuram will issue necessary posting orders to Sri.Davis Richard, after verification of the original documents produced by him to prove age, educational qualification, medical fitness and after confirming the genuineness of the same and also subject to other conditions under the scheme in force.
