## ORDER

As per Government Order read as 2<sup>nd</sup> above, Administrative sanction was accorded for the installation of High-mast / Mini-mast light in various places of Nemom Legislative Assembly Constituency under LAC-ADS of Sri.O.Rajagopal, MLA. The sanction was accorded subject to the condition that the work shall be executed in strict adherence of order read as 2<sup>nd</sup> above wherein guidelines were issued by Finance Department on projects for installation of high-mast / mini-mast lights under LAC-ADS. However Finance Department has subsequently issued modified orders as per order read as 3<sup>nd</sup> above wherein it is ordered that the provision of the order read as 1<sup>st</sup> above, will be applicable only from 2018-19 financial year and the works for 2016-17 which are yet to be implemented, can be executed following the procedure adopted up to 2015-16.

- 2) Government hereby order that the provisions of the order read as 1<sup>st</sup> above, will not be applicable for the works for which sanction was accorded as per Order read as 2<sup>nd</sup> above for the installation of High-mast / Mini-mast light in various places of Nemom Legislative Assembly Constituency under LAC-ADS of Sri.O.Rajagopal, MLA and this work can be executed following the procedure adopted upto 2015-16.
  - 3) The Government order read as 2<sup>nd</sup> above stands modified to the above extent.
