As per letter read as 2nd above, Sri.K.Ansalan MLA of Neyyattinkara LAC has requested to issue Administrative Sanction for the works "Improvements of Plavila-Poly-Thachikulam-Vanadurga road in Neyyattinkara Municipality" and "Improvement of RC Street – Kalluvila – Kavalakulam - Sasthamthala Road in Neyyattinkara Municipality" under Legislative Assembly Constituency – Asset Development Scheme.

2. The Chief Engineer, LSGD as per letter read as 3rd above, has submitted the Detailed Project Reports for the above works.

3. Government have examined the matter in detail and are pleased to accord administrative sanction for the following works from the Asset Development Fund for the year 2016-17 of Sri. K. Ansalan, MLA of Neyyattinkara.

- (i) Improvement of Plavila -Poly-Thachikulam- Vanadurga road in Neyyattinkara Municipality - Rs. 31,67,572.67 (ie Rs.35,00,000 - ST 3,32,427.33)
(ii) Improvement of RC Street-Kalluvila-Kavalakulam-Sasthamthala Road in Neyyattinkara Municipality – Rs. 2715006.4 (ie. Rs.30,00,000– ST 2,84,993.6)
