As per letters read as 2nd paper above, Sri.Chittayam Gopakumar, MLA of Adoor LAC has requested to issue Administrative Sanction for the works "Improvements of Sreemoolam market to Pampettu Kulam deviation Road in Adoor Municipality" and "Improvements of Thodiyil Bhagam - Ayyappasadänam Road in Kadampanadu Panchayat" under Legislative Assembly Constituency – Asset Development Scheme.

2. The Chief Engineer, PWD Roads & Bridges as per letter read as 3rd above, has submitted the Detailed Project Reports for the above works.

3. Government have examined the matter in detail and are pleased to accord administrative sanction for the following works from the Asset Development Fund of Sri. Chittayam Gopakumar , MLA, Adoor LAC.

- (i) Improvements of Sreemoolam market to Pampettu Kulam deviation Road in Adoor Municipality – Rs. 36,45,444/- (excluding the lumpsum provision of Rs.54,556/- included in the estimate, from Rs. 37,00,000/-)
(ii) Improvements of Thodiyil Bhagam - Ayyappasadanam Road in Kadampanadu Panchayat - Rs.25 lakhs

4. The work shall be executed in strict adherence of all departmental formalities and in tune with the guidelines issued by the Government in the Order read above. The expenditure for the work will be debited under the Head of Account "4515-00-800-96-Projects under LAC ADS (NP)".
