## **ORDER**

As per Government Order read as 1st paper above, administrative sanction was accorded for the implementation of the plan scheme "Reseach studies under MGNREGS-State Share" for undertaking a research oriented study to measure the outcomes and impact of implementation of Mahatma Gandhi National Rural Employment Guarantee Scheme in rural areas of the state for the last 10 years with special focus on sectors like agriculture, irrigation and women empowerment.
