### ORDER

Sri. Arun T, S/o late Many K.M. Secretary, Junior Superintendent, Perambra Grama Panchayat, Kozhikode District has applied for employment assistance under the Compassionate Employment Scheme. The deceased Government servant had put in a total service of 22 years and 12 days.

The applicant is 19 years of age as his date of birth is 16.10.1996. He has passed SSLC. The Director of Panchayats and the District Collector, Kannur as per the letters read as 4<sup>th</sup> and 5<sup>th</sup> paper above have recommended the application of Sri. Arun T. All the legal heirs of the deceased have relinquished their claims in favour of the applicant and have given consent statements. The applicant is a real dependent of the deceased. None of the dependents of the deceased has applied for availing the benefit under the scheme earlier. No other family members of the applicant has got appointment under the scheme.

The District Collector, Kannur as per the letter read as 5<sup>th</sup> paper above has reported that the annual family income of the deceased Government servant is Rs.18,000/- (Rupees Eighteen Thousand only).

In the above circumstances sanction is accorded to the Director of Panchayats, to appoint Sri. Arun T, S/o late Many K.M, Junior Superintendent, Perambra Grama Panchayat, Kozhikode District in the existing/arising vacancy of the Lower Division Clerk in Kannur District under the Compassionate Employment Scheme subject to the conditions laid down in the Government Orders read as 1<sup>st</sup> and 2<sup>nd</sup> paper above, after verifying all the original certificates.

Necessary entries shall be made in the Service Book of the deceased employee and in the Establishment Register regarding the grant of employment to the dependent as stipulated in the Government Order read as 1<sup>st</sup> paper above.


The employment assistance under the scheme will be cancelled if and when it is found that there is any misrepresentation or suppression of material facts on the part of the incumbent in the course of enquiry conducted by various Government agencies.
