### ORDER

The Senior Manager(Commercial), Steel Industries Kerala Limited, Thrissur has furnished detailed estimate on the Installation of Minimast Lights at 27 locations in Malappuram LAC at an estimated cost of Rs. 54 Lakh (Rupees Fifty Four Lakh only) as per the reference read as 4<sup>th</sup> paper above to accord Administrative Sanction and Special Sanction as proposed by Sri. P. Ubaidulla, MLA representing Malappuram Constituency. The respective Grama Panchayats have passed resolutions and forwarded the same in this regard.

2) Government have examined the matter in detail and are pleased to accord Administrative Sanction on the Installation of Minimast Lights at 27 locations in Malappuram LAC under LAC-ADS of Sri. P. Ubaidulla, MLA representing Malappuram Constituency, at an estimated cost of Rs. 54 Lakh (Rupees Fifty Four Lakh only) with Special Sanction to take up the work for execution as deposit work through Steel Industries Kerala Limited, Thrissur following all departmental formalities and in tune with the guidelines issued in the Government Order read as 1<sup>st</sup> paper above and subsequent Government orders, subject to the condition that the


rates may be fixed by SILK after observing tender formalities. The Chief Engineer, Local Self Government Department should take necessary action to deposit the required amount to Steel Industries Kerala Limited, Thrissur , the executing agency, as envisaged in the Circular read above.
