ORDER

As per the Government Order read as 1st paper above,Government have accorded sanction for setting up of an independent Social Audit Society Registered under Travancore Cochin Literary, Scientific & Charitable Societies Act 1955 for the conduct of Social Audit of Mahatma Gandhi NREGA. A Governing Body for the Society was constituted as per the GO read as 2nd paper above.

2. The day to day affairs and the conduct of Social Audit is vested with team of officials consisting of a Director, Social Development Specialist and three Experts in the Social Audit Unit at the State level. As per the instructions contained in clause 2.9.1.7 of MGNREGS Master Circular, notification shall be issued by entrusting the selection of the social audit resource persons from the short list prepared by the Social Audit Unit. The Mission Director as per the letter read above, has informed that fresh applications were invited for the posts of Director, Social Development Specialist and three Experts in the Social Audit Unit. The shortlisted applications were approved by the Governing Body on 5.6.2017. The Mission Director(MGNREGS) in his letter read above, has proposed a selection committee with a structure in line with the para iii(b) of the Office Memorandum read above issued by Government of India in this regard wherein Principal Accountant General/Accountant General in charge of Local Bodies (Audit) is included as a member.

3. Govt have examined the matter and are pleased to reconstitute a Selection Committee in the following composition for the purpose of the selection of the social audit resource persons (Director, Social Development Specialist and three experts) in the Social Audit Unit of MGNREGS State Mission.
