2) Government have examined the matter in detail and are pleased to accord Administrative Sanction for the work Improvements to Ummermukku-Kannattumukku Road in Muthukulam Grama Panchayat proposed under LAC-ADS of Sri. Ramesh Chennithala, MLA representing Harippad Constituency for the year 2016-17 at an estimated cost of Rs. 100,00,000/- (Rupees One Hundred Lakh only) by utilizing an amount of Rs. 66.35 Lakhs from the Asset Development fund for the year 2016-17 and the remaining amount from the fund 2017-18 with Special Sanction to take up the work for execution, as deposit work through PWD,subject to the

resolution passed by the concerned Local Body in this regard, following all departmental formalities and in tune with the guidelines issued in the Government Order read as 1st paper above and subsequent Government orders. The Chief Engineer, Local Self Government Department should take necessary action to deposit the required amount to PWD as envisaged in the Circular read above.


3) The expenditure in this regard shall be debited to the Head of Account '4515-00-800-96-Projects under LAC-ADS(NP)'.
