ORDER

As per the letters read from 2nd to 10th papers above, the Ministry Of Rural Development, Government of India has sanctioned an amount of Rs.30,76,82,000/- (Rupees Thirty Crore seventy Six Lakh and Eighty two thousand only) as the balance of 1st installment towards additional target of central assistance under PMAY (G) scheme including administration fund for 2016-17. In the letters read as 11th paper above, the Commissioner for Rural Development has submitted proposal for the release of an amount of Rs.51,28,03,334/- as the Central share and corresponding state share including the administration fund for the Year 2016-2017.

After having examined the matter in detail, Government are pleased to accord sanction and to authorise the Commissioner for Rural Development to release an amount of Rs.51,28,03,334/- (Rupees Fifty one Crore Twenty eight Lakh Three Thousand Three Hundred and Thirty Four Only) towards the balance of 1st installment of additional target of central assistance under PMAY (G) scheme and the corresponding state share for the scheme including administration fund for the year 2016-17, from the Current Year's Budget Provision, as detailed below:
