Government have examined the proposal in detail and are pleased to accord permissive sanction to all Grama Panchayaths, Municipalities in Palakkad district and Valavaunnur, Vettom, Thavanur and Marancherry Grama Panchayaths and Parappanangadi Municipality (for Neduva Coastal Block) in Malappuram district to give financial support to the concerned CHC/PHC/Hospital on the decision taken in their Committee/Council for the Mass Drug Administration Programme 2017 at the following

rates from their own fund.
