ORDER

As per the representation read as 1st paper above, Shri. Reghuraman, Municipal Secretary Grade I, Palakkad Municipality has contended that the Departmental Promotion Committee (Higher) met on 27.03.2017 and the adhoc Departmental Promotion Committee (Higher) met on 27.09.2017 has not recommended his name for inclusion in the select list for promotion to the cadre of Corporation Secretary/Additional Corporation Secretary and hence he has requested to convene a review Departmental Promotion Committee (Higher) and to include his name in the select list of Corporation Secretary in accordance with his seniority.

2. In the connection with the above, Shri.Reghuraman filed O.A. (EKM) No. 1913/17 before the Hon'ble Kerala Administrative Tribunal. The Hon'ble Kerala Administrative Tribunal, as per the Order read as 2nd paper above, has directed the 2nd respondent [Convenor, Departmental Promotion Committee (Higher)] to cause the disposal Annexure MA1 Representation by convening a meeting of review Departmental Promotion Committee (Higher), as expeditiously as possible, at any rate before the next meeting of the regular Departmental Promotion Committee or within one month, whichever is earlier.

3. Hence, review Departmental Promotion Committee (Higher) has convened on 14.12.2017. The Committee examined the matter in detail and noted that disciplinary action for major penalty in one case and that for minor penalty in 14 cases are pending against Shri.Reghuraman and hence decided not to recommend the name of Shri.Reghuraman for inclusion in the select list for promotion to the post of Corporation Secretary/ Additional Corporation Secretary, as per Note (i) to Rule 28(b)(i)(7) of Kerala State and Subordinate Service Rules 1958.

4. Hence, the order of the Hon'ble Kerala Administrative Tribunal read as 2nd paper above is thus complied with.
