i.e. Assistant Director of Panchayats since 30.05.2013 than the above mentioned seniors. Smt. K.R. Prabha cannot be reverted to the lower post on the basis of the select list as the Hon'ble Supreme Court in the order dated 29.03.2017 in Civil Appeal No.5203/2016 & connected cases has already directed the Government that no reversion be effected without obtaining prior consent from the Hon'ble Supreme Court. In this circumstance Sri. P. N. Aboobacker Siddique, Sri. Salim Gopal, Sri. Joy John and Sri. K. Sudhakaran are notionally promoted to the post of Assistant Director of Panchayats w.e.f. 30.05.2013 the date on which their Junior Smt. K.R. Prabha was promoted to the post of Assistant Director of Panchayats. They will be eligible for promotion to the post of Deputy Director of Panchayats only on successful completion of their probation in the cadre of Assistant Director of Panchayats. Director of Panchayats will furnish necessary proposal in this regard.
