ORDER

Smt. Bindu Jasmin. W.S, Asst.Exe.Engineer, Kondotty Block Panchayath was transferred to Kunnumel Block Panchayath as per Government Order read as 1st paper above. Aggrieved by this transfer, Smt. Bindu Jasmin. W.S has filed OA(EKM) No.1964/2017 before Hon'ble Kerala Administrative Tribunal . The Hon' KAT as per its interim order dated 13.09.2017 have stayed the implementation of the above transfer order and she is still continuing in the Kondotty Block Panchayath .

- 2. As per the Order read as 2nd paper above, the Hon'ble Kerala Administrative Tribunal have disposed of OA(EKM) No.1964/2017 directing the Ist respondent, the Government to take a decision on Annexure A5 representation, read as 3rd paper above, after hearing the applicant within a period of 3 months from the date of receipt of a certified copy of the order. The applicant has submitted the copy of the Hon' KAT along with the OA, which had been received in Government on 06.11.2017.
- 3. In pursuant to the Hon' KAT direction, the Under Secretary, LSGD heard the applicant on 21.12.2017.
- 4. During the hearing the applicant has contended that Kunnummal Block Panchayat, a place 80 km away from her residence is resulting in a travel of 160 kilometres per day and she has to board three different buses to reach the place. In the middle of the academic year, her two small girl children can neither be shifted to a new school nor it is very difficult to shift her residence to such a far off place. Her children are studying in a nearby school and the elder child had undergone cardiac surgery twice and the follow up is being done at Amritha

Institue of Medical Scieces, Kochi. So her presence in the vicinity is needed. It is informed that she had been denied transfer during the General Transfer 2017, in which she had opted for Thirurangady and Thanur Block Panchayaths. Vacancy at Kunnummal Block Panchayath has also been filled. Even though a native of Thiruvananthapuram District, she has been working out of her home district from 2004 onwards. Hence she has requested to allow her to continue in the present position,ie, Block Panchayat, Kondotty or the places opted by her during the General Transfer 2017.

- 5. The Chief Engineer has reported that the petitioner had been transferred to Kunnummel Block Panchayat on administrative convenience. As the stay order is in force, in Kunnummal Block Panchayat, where the applicant is under orders of transfer, Smt. Gracy Joseph has been posted vide GO (Rt) No. 3604/2017/ LSGD dated 7.11.2107. Also the vacancy at Thirurangady Block Panchayath has also been filled. Accordingly, the Chief Engineer has proposed that the applicant may be transferred and posted to any of the vacancies existing at Chavakkad Block Panchayath or Thrissur Corporation.
- 6. Government have examined the matter in detail and are pleased to transfer Smt. Bindu Jasmin.W.S, Asst.Exe.Engineer, Kondotty Block Panchayath to Chavakkad Block Panchayath in the existing vacancy, with immediate effect.
- 7. The order of the Hon'ble KAT in OA(EKM) No.1964/2017 read as 2^{nd} paper above, is complied with accordingly.
