transparent bidding process . The Chief Engineer, LSGD should also ensure that the estimates are prepared as per PWD schedule of rates before giving Technical Sanction


3)The Chief Engineer, Local Self Government Department should take necessary action to deposit the required amount to Steel Industries Limited Kerala , the executing agency, as envisaged in the circular read above.
