ORDER

In compliance with the directions of the Hon'ble Kerala Administrative Tribunal, the name of the applicant has been included in the field of choice for preparing the select list for promotion to the post of Joint Development Commissioners. The Departmental Promotion Committee held on 06.03.2018 decided not to include Sri. K. M. Sasidharan in the select list for promotion to cadre of Joint Development Commissioner for the year 2018, as disciplinary action/Vigilance case was pending against him.

3. The order of the Hon'ble Kerala Administrative Tribunal, read as 2nd paper above, is thus complied with.
