ORDER

The Secretary, Kerala Public Service Commission as per letter read as 1st paper above has advised Smt. Asha V., Makam, TC 11/832(1), Lane H(4), Krishna Nagar, Ulloor, Pattom Palace P.O., Thiruvananthapuram for appointment to the post of Lecturer Grade I (Rural Engineering) (By Transfer Recruitment) in the scale of pay Rs.20,740 – 36,140/-.

2. As per the letter read as 2nd paper above, the Commissioner for Rural Development has reported two vacancies in the post of Lecturer Grade I, Rural Engineering (Direct Recruitment) in the KILA - Centre for Good Governance, Mannuthi (formerly ETC, Mannuthi) and KILA - Centre for Socio-Economic Development, Kottarakkara (formerly ETC, Kottarakkara).

3. In the above circumstances, Government are pleased to appoint Smt. Asha V., Makam, TC 11/832(1), Lane H(4), Krishna Nagar, Ulloor, Pattom Palace P.O., Thiruvananthapuram as Lecturer Grade I, Animal Husbandry (By Transfer Recruitment) in the KILA - Centre for Socio-Economic Development,

Kottarakkara (formerly ETC, Kottarakkara) in the existing vacancy in the Scale of Pay Rs.20,740 – 36,140 on provisional basis under Rule 9 (a) (i) of the General Rules KS & SSRs, 1958 as provided for in Rule 10 (b) of those rules. The advice of the candidate is subject to the Rule 3 (c) of the General Rules of the KS & SSRs, 1958.

4. The Candidate is directed to report for duty before the Principal, KILA - Centre for Socio-Economic Development, Kottarakkara within 15 days from the date of receipt of the appointment order, failing which the appointment order will be cancelled and the Kerala Public Service Commission will be advised to cancel the advice without any further notice. The candidate should bring with her the original documents to prove Age, Educational qualifications and Original One Time Verification Certificate, failing which she will not be admitted to duty. The candidate should also produce Medical Certificate [as prescribed in Rule 13, Part I, Kerala Service Rules and G.O. (P) 20/2011/P&ARD dated 30.06.2011] carrying thumb impression and passport size photograph signed by a Medical Officer not below the rank of a **Civil Surgeon**, three passport size photographs (duly attested on the reverse side) by a Gazetted Officer of State Government Service and AADHAR Card (UID Card) as stipulated in Circular No. 12521/AVC VI (3)/13/P&ARD dated 26.07.2013, so as to verify the identity. If the candidate is not in possession of the AADHAR Card, Voter ID Card/ PAN CARD should be produced. If the candidate is already employed in Government Service / Public Service Undertakings etc., she should produce necessary relieving orders, failing which the candidate will not be admitted to duty.

5. The candidate should produce Community / Non Creamy Layer Certificate in original for verification when she reports for duty, if applicable.

6. The candidate is informed that in the event of discharge from service for want of vacancies, she may either re-register her name in the office of the Kerala Public Service Commission and get re-appointed on further advice from the Kerala Public Service Commission in which case the candidate shall lost the right of probation to the post in the department from which the candidate was discharged for want of vacancies or may wait for her turn for re-appointment to the post in the department in case the candidate desires to continue as probationer in the post from which she was discharged.

7. The date of joining duty of the candidate should be reported to the Kerala Public Service Commission and to the Government immediately after the candidate joins duty. In case, the candidate does not join duty within the joining time allowed in the appointment order, the fact should be reported to the Kerala Public Service Commission as well as the Government immediately.


