## ORDER

Sri. Manojith Pasand, Assistant Development Commissioner has filed OA No.187/17 before the Hon'ble Kerala Administrative Tribunal for the restoration of due promotion, which was denied even after he was acquitted in the vigilance case. The Hon'ble Kerala Administrative Tribunal as per order read as 1<sup>st</sup> paper above, directed the 1<sup>st</sup> respondent ie. Secretary to Government, Local Self Government Department, to issue necessary orders to include the applicant in the select list dated 31.03.2010 for promotion to the post of Assistant Development Commissioner for the year 2010 and promoted to the post with effect from 22.05.2010 and also to promote as Deputy Development Commissioner with effect from 06.02.2016, the dates on which his immediate junior (Sri.K.R. Devadas) was promoted as Deputy Development Commissioner within two months from the date of receipt of a certified copy of the order.

2. The Commissioner for Rural Development as per letter read as 2<sup>nd</sup> paper above, informed that for the compliance of the Judgment of the Hon'ble Kerala Administrative Tribunal, the revision of the select list for promotion to the cadre of Assistant Development Commissioner for the year 2010 and for the revision of the select list for promotion to the cadre of Deputy Development Commissioner for the year 2015 are necessary. Accordingly select lists were modified to include Sri. Manojith Pasand as per notification read as 3<sup>rd</sup> paper above.

- 3. Government have examined the matter in detail and are pleased to grant Sri. Manojith Pasand, notional promotion to the post of Assistant Development Commissioner with effect from the date on which his immediate junior, Sri.K.P.Devadas, took charge in the post of Assistant Development Commissioner vide GO(Rt) No.1712/2010/LSGD dtd 22.05.2010 and to the post of Deputy Development Commissioner with effect from the date on which his immediate junior, Sri.K.P.Devadas, took charge in the post of Deputy Development Commissioner vide GO(Rt)No.481/ 2016/LSGD dtd 06.02.2016, subject to the condition that he will not be eligible for back arrears of pay and allowances but will be eligible for revision of pensionery benefits.
- 4. The order of the Hon'ble Kerala Administrative Tribunal dated 31.01.2018 is thus complied with.
