**ORDER**

Sri.Mahesh Kumar M., Brother of Late Vidya M.Nair, who died in harness on 30/09/2016 while working as U.D.Typist in LSGD Sub Division, Ranni Block Panchayat, Pathanamthitta, has applied for employment assistance under the Compassionate Employment Scheme as per the application read as 2<sup>nd</sup> paper above. The application was submitted within the prescribed time limit. The deceased Government servant put in a total service of 2 years 5 Months and 23 days.

2. The applicant is 27 years old as his date of birth is 04/01/1991. He has passed Higher Secondary Examination. The request is for appointment in the post of Clerk and he is qualified for that post.

3. The Chief Engineer, LSGD, Thiruvananthapuram and the District Collector, Thrissur as per the letters read as 3<sup>rd</sup> and 4<sup>th</sup> papers above have recommended the request of Sri.Mahesh Kumar. M, Smt. Radhamony V.G., Mother of the deceased, has given her consent for providing employment in respect of Sri.Mahesh Kumar M. The applicant is the brother of the deceased. The annual family income of the deceased Government Servant is ₹ 3,55,800/- (Rupees Three lakh fifty five thousand and eight hundred only).

4. In the circumstances, Government are pleased to accord sanction for the appointment of Sri.Mahesh Kumar M, brother of Late Vidya M.Nair as Clerk in the Local Self Government (Engineering Wing) Department in Pathanamthitta District in the existing or next arising vacancy under the Compassionate Employment Scheme, subject to the conditions laid down in the Government Order read as 1<sup>st</sup> paper above. Necessary entries in this regard will be made in the Service Book of the deceased Government servant and also in the Establishment Register of the office where the deceased employee last worked and the entries will be attested by the Head of Office/Head of Department.

5. The employment assistance ordered under the scheme will be cancelled if and when Government find that there was any suppression or misrepresentation of material facts on the part of the applicant at the time of forwarding the application or during the course of inquiry conducted by the Department in which he is appointed.

6. The Chief Engineer, Local Self Government Department, Thiruvananthapuram will issue necessary posting orders to Sri.Mahesh Kumar M., after verification of the original documents produced by him to prove age, educational qualification, medical fitness and after confirming the genuineness of the same and also subject to other conditions under the scheme in force.
