ORDER

By disposing of the OAs read as 4th paper above, Hon'ble Kerala Administrative Tribunal has directed the 4th respondent i.e, Secretary to Government, LSGD to consider and pass appropriate orders on Annexure A12 in OA(EKM)No.321/2018, Annexure A12 in OA(EKM) No.438/2018, Annexure A13 in OA(EKM)No.597 of 2018, Annexure A10 in OA(EKM) No.600 of 2018, Annexure A14 in OA(EKM)No.601of 2018, Annexure A12 in OA(EKM) No.603 of 2018 and Annexure A11 in OA(EKM) No.604 of 2018 in accordance with law within a period of two months from the date of receipt of a copy of the order. The contentions advanced by the petitioners were similar in all the OAs, i.e to sanction the benefits of the 10th Pay Revision on par with the one sanctioned to Government employees vide Government Order read as 1st paper above.

2.The petitioners in the Original Applications, read as 4th Paper above are retired employees of Calicut Development Authority of various designations mentioned in the table below.

As per the Government Order read as 2nd paper above, the benefits of the 9th Pay Revision was sanctioned to the employees of Calicut Development Authority (Defunct) excluding the post of Section Officer (Higher Grade) and limiting the same to Section Officers. Aggrieved by this, Sri. V. R. Sasidharan, who retired from the post of

Section Officer (Higher Grade), Calicut Development Authority (Defunct), had filed WP(C)No.17250/2016(E) before the Hon'ble High Court in which the Interim Order of the Hon'ble Court was complied by the issuance of the Order read as 3rd Paper above and the petitioner had been granted the benefits of 10th Pay revision to the post of Section Officer (Higher Grade).

4. In pursuance of the direction contained in the Court Orders, Government have examined the matter in detail and are pleased to grant the benefits of the 10th Pay Revision sanctioned on par with the Government employees, vide GO read as 1st paper above, to the petitioners who are listed in the table above, as a special case, similar to the Order issued by Government vide GO read as 3rd Paper above, to comply with the Orders pronounced in OA(EKM)No.321/2018, OA (EKM)No. 438/2018, OA(EKM)No.597/2018, 600/2018, 601/2018, 603/2018 and 604/2018.

5. The Secretary, Kozhikode Municipal Corporation shall take urgent action required for the disbursement of the benefits of Pay Revision as stated above to the petitioners.

6. The direction contained in the Court Orders read as 4th Paper above is complied with accordingly.
