ORDER

Considering in exigency of service 14 Assistant Directors of Panchayats were provisionally promoted to the cadre of Deputy Director of panchayats as per Government Order read as 1st paper above even before completing their period of probation in the cadre of Assistant Director of Panchayats on condition that their service in the promoted category will be regularized only from the date of declaration of probation in the feeder category of Assistant Director of Panchayats.
