ORDER

The Hon'ble Kerala Administrative Tribunal as per the order read as 3rd paper above has disposed of the M A. No. 2248/2018 filed by Sri. M. Vivek, L.D Clerk in the OA No.785/2018 filed by Shri.Vinod Kumar.T.K, Senior Clerk with a direction to the respondents to take a decision over the dispute regarding the transfer of Sri. M. Vivek, L.D Clerk and Sri.Vinod Kumar T.K, Senior Clerk.

2. As per the order read 2nd as above, Sri.M.Vivek, L.D.Clerk and Sri.Vinod Kumar.T.K, Senior Clerk were transferred to the office of the Town Planning Office, Palakkad and Chief Town Planning Office, Thiruvananthapuram respectively. Aggrieved at the above order, Sri.Vinod Kumar.T.K filed O.A before the Hon'ble Kerala Administrative Tribunal and subsequently the transfer order has been stayed temporary.

3. Government have considered the Order read as 3rd above and subsequently issued an order read as 5th above. Hon'ble Tribunal examined the Government Order and found that the same is not in accordance with the directions of the Hon'ble Tribunal and hence directed Government to recall the order and issue proper order in accordance with the directions of the Hon'ble Tribunal.

4. Government have examined the matter in detail in the light of the judgment read 6th as above and the report furnished by the Chief Town Planner. The Chief Town Planner has reported that a post of L.D Clerk may be shifted from Thiruvananthapuram to Palakkad District to post Sri. M. Vivek in Palakkad District so as to enable him to look after his mother who is bedridden.

5. In the circumstances, Government are pleased to recall the order read as 5th paper above and ordered to shift one post of L.D.Clerk from the office of the Chief Town Planner, Thiruvananthapuram to Palakkad District Town Planning office and to post Sri. M. Vivek, L.D Clerk in Palakkad District in the shifted post. The Chief Town Planner will initiate further action in the matter.

6. The order of the Hon'ble Kerala Administrative Tribunal read as 6th paper above is thus complied with.


