

<u>Abstract</u>

Finance Department - Budget Estimates 2018-19 – Fund for Expansion and Development – Authorization of Performance Grant under 14th Finance Commission Grant to Rural Local Governments (RLGs) and Urban Local Governments (ULGs) – Modified Orders issued.

ORDER

As per Government order read above, Performance Grant under 14th Finance Commission Award amounting to ₹285,94,00,000/- (Rupees Two hundred and Eighty Five crore Ninety Four lakhs only) has been authorized to 492 Grama Panchayats, 71 Municipalities and 6 Municipal Corporations.

- 2. Now it has come to the notice of the Government that 6 Municipal Corporations and 75 Municipalities are eligible for Performance Grant for the Financial Year 2018-19.
- 3. The new heads of account cited in the Government order read above to provide the Performance Grant amount shall come into force only with effect from the financial year 2019-20. Hence, there is no change in the heads of account provided for 14th Finance Commission Award for the year 2018-19.
- 4. Government have examined the matter in detail and are pleased to modify the Government order read above as follows:
 - a) Authorization for Performance Grant for the fiancial year 2018-19 under 14th Finance Commission Award amounting to ₹285,94,00,000/- (Rupees Two hundred and Eighty Five crore Ninety Four lakhs only) is issued to 492 Grama Panchayats, 75 Municiplities and 6 Municipal Corporations as detailed below:
