#### ORDER

As per order read as 1<sup>st</sup> paper above the Hon'ble Enquiry Commissioner and Special Judge, Kottayam in C.C. 219 of 2008 convicted Shri. C.K Bhaskaran, former Head Clerk, Kozhuvanal Grama Panchayath for one year rigorous imprisonment and fine of Rs. 25000/- under Prevention of Corruption Act, 1988, again two years rigorous imprisonment and fine of Rs.25000/- under section 409 of I.P.C and again rigorous imprisonment for one year under section 120 B of I.P.C. on the proved charges. Hon'ble Court also convicted Shri. K.M. Thomas, former Peon, Kozhuvanal Grama Panchayath for one year rigorous imprisonment and fine of Rs. 25000/- under Prevention of Corruption Act 1988 on the proved charges under Sec.13(1)(c)r/w Sec.13(2)of Prevention of Corruption Act and again rigorous imprisonment for one year under section 120B of I.P.C.

As both the officers were retired on superannuation and are receiving pension, after observing the procedural formalities Government have tentatively decided to withhold pension other than minimum pension of both the officers for a period of five years under Rule 2, Part 3,

KSR and as per 3<sup>rd</sup> paper read above Show Cause Notice was served on to them. In their statement of defence as per 4<sup>th</sup> & 5<sup>th</sup> read above stated that the order of the Vigilance court has been challenged before the Hon'ble High Court and the Hon'ble High court has freezed the verdict of the Vigilance Court. As now the case is under the consideration of the Hon'ble High Court action could not be taken against them.

Government have examined the matter in detail. Hon'ble High court has only stayed the execution of sentence and there was no stay in conviction and there is no legal bar in continuing the disciplinary proceedings against the accused officers. The reply submitted by the accused officers is not found satisfactory. In the circumstances Government have decided to confirm its tentative decision to deduct pension other than minimum pension for 5 years in respect of Sri. C.K. Bhaskaran, Head Clerk (Rtd.) and Sri. K.M. Thomas, Peon,(Rtd) Kozhuvanal Grama Panchayat was placed before the Kerala Public Service Commission for advice. The Commission as per 6<sup>th</sup> paper read above has agreed to the aforesaid tentative decision and advised accordingly.

In the above circumstances the action initiated against Sri. C.K. Bhaskaran, Head Clerk (Rtd.) and Sri. K.M. Thomas, Peon (Rtd.), Kozhuvanal Grama Panchayat are finalized by confirming the tentative decision to deduct pension other than minimum pension for 5 years and order accordingly. The Director of Panchayats will take further necessary action in the matter.
