ORDER

Pradhan Mantri Gramin Sadak Yojana is a Centrally Sponsored Scheme launched on 25th December, 2000 with a view to establish Rural Connectivity and Connecting Unconnected Habitations with all weather roads of high quality. Present funding pattern of PMGSY is 60:40 between the Central and State Government. In addition to the State Share, an additional State Share Viz. Pradhan Mantri Grama Sadak Yojana (Additional State Share) is provided by State Government in the Budget every year for meeting tender premium over and above the estimate cost, utility shifting, 5 year maintenance of completed roads and maintenance of PMGSY roads which had completed defect liability period. An amount of Rs. 5,000 lakhs is earmarked under the Head of Account 4515-00-800-98-03 in the current year's Budget for 'Pradhan Mantri Grama Sadak Yojana (Additional State Share) scheme. As per PMGSY guidelines the tender premium over and above the estimate cost and the excess amount for the revised estimate sanctioned should be met by State Government.

2. As per the letter read as 2nd paper above, the Commissioner for Rural Development has submitted proposal for Administrative Sanction for an amount of ₹5000 Lakh under the Head of Account 4515-00-800-98-03 for the implementation of PMGSY scheme. The component wise details of the above State Plan Scheme is as follows:-

3. Government have examined the matter in detail Pradhan Mantri Grama Sadak Yojana is a continuing scheme. There is no variation from the Scheme operational during the year 2018-19 in terms of components, scope, unit costs, etc. and does not include fresh post creation and purchase of vehicle.

4. In the above circumstances, Government are pleased to accord Administrative Sanction for the scheme "Pradhan Mantri Grama Sadak Yojana (Additional State Share)" for an amount of Rs. 5000 lakh (Rupees Fifty Crore only) for the financial year 2019-2020.

5. The expenditure in this regard shall be met from the Head of Account 4515-00-800-98-03 in the current year's(2019-20) budget provision.


