**ORDER**

Departmental Promotion Committee (II) held on 14.08.2018 has considered the claim of Sri. Sidheek K, Performance Audit Supervisor, Performance Audit Unit-6, Thalakkad, Malappuram to include his name in the select list for promotion to the cadre of Assistant Director of Panchayat and noticed that the disciplinary action for major penalty is pending against him. Taking into consideration of the above fact, the Departmental Promotion Committee (II) held on 14.08.2018 has decided not to include him in the select list for promotion to the cadre of Assistant Director of Panchayats. For this reason Sri. Sidheek has submitted a review petition read as 2<sup>nd</sup> paper above before the convenor of the Departmental Promotion Committee (II) and filed O.A.No. 1785/2018 before the Hon'ble Kerala Administrative Tribunal.

2. As per the order read as 3<sup>rd</sup> paper above the Hon'ble Kerala Administrative Tribunal has directed the Second respondent i.e. the convenor of the Departmental Promotion Committee (II) to cause disposal of Annexure A8, (review petition dated 07.09.2018), statutory representation by convening the adhoc DPC as expeditiously as possible, at any rate, within the period of two months from the date of receipt of the certified copy of this order which will be produced along with a copy of the Original Application before the Second respondent.

3. On the basis of the order of the Hon'ble Kerala Administrative

Tribunal the petitioner was included in the field of choice of Assistant Director of Panchayats and the Departmental Promotion Committee (II) held on 12.02.2019 assessed the suitability of Sri. Sidheek K. for promotion to the cadre of Assistant Director of Panchayats after verifying the Annual Confidential Reports for the last 3 years . Self Appraisal report on the work under taken by him and the details of disciplinary action pending against him for assessing his eligibility for inclusion in the select list.

The Departmental Promotion Committee (II) held on 12.02.2019 noticed that the disciplinary action for major penalty is pending against him. Taking into consideration of the fact, the Departmental Promotion Committee (II) decided not to include his name in the select list for promotion to the cadre of Assistant Director of Panchayats.

5. The minutes of the Departmental Promotion Committee (II) meeting held on 12.02.2019 has been approved and select list for Assistant Director of Panchayat is published vide Government Order read as 1<sup>st</sup> paper above.


6. The order of the Hon'ble Kerala Administrative Tribunal read as 2<sup>nd</sup> paper above is thus complied with.
