ORDER

As per letter read as 1st paper above Government of India have sanctioned ₹5,11,00,000/- (Rupees Five Crore Eleven Lakh only) to the State of Kerala for 'Financial Incentive' as central assistance for the Financial Year 2018-19. It is instructed therein that the funds are exclusively meant for periodic maintenance of roads already constructed under Pradhan Mantri Gram Sadak Yoajana and directed to credit the amount in the savings bank account of KSRRDA, which is linked with PFMS and monitored by the online software called OMMAS. As per the letter read as 2nd paper above, the Member Secretary, KSRRDA has submitted proposal for the release of the aforesaid central share and corresponding state share (40%) of ₹3,40,66,666/- (Rupees Three Crore Forty Lakhs Sixty Six Thousand Six Hundred and Sixty Six only).

Government have examined the matter in detail and are pleased to accord sanction to release an amount of ₹5,11,00,000/- (Rupees Five Crore Eleven Lakh only) from the h/a 2515-800-74-01 and ₹3,40,66,666/- (Rupees Three Crore Forty Lakhs Sixty Six Thousand Six Hundred and Sixty Six only) from the h/a 2515-800-74-02 as the central share and corresponding state share respectively of Financial Incentive under the scheme PMGSY, 2018-19.
