ORDER

As per the order read as 1st paper above the Hon'ble Kerala Administrative Tribunal has directed the 1st & 2nd Respondents to take appropriate action to get the matter considered by the Departmental Promotion Committee within four months from the date of receipt of the representation of the petitioner.

- 2. The applicant, who was as Assistant Secretary in Vallachira Grama Panchayat, filed the aforesaid O.A., complaining that her claim for promotion to the post of Secretary was not being considered, apparently for the reason that her probation in the cadre of Assistant Secretary had not been declared. As per the direction of the Hon'ble Tribunal, the applicant has submitted a representation to Government to pass orders including her name in the appropriate place in the select list for the year 2015, for promotion to the post of Secretary and to promote her to the said post with retrospective effect with all the benefits and also to include her name in the appropriate position in the final seniority list of Secretary, Grama Panchayat dated 02.06.2018.
- 3. Government have examined the matter in detail. The claim of the applicant should be considered by the Departmental Promotion Committee

(Lower). The convener of the DPC (Lower) is the Director of Panchayats and he also the appointing authority of the Secretary, Grama Panchayats. In the above circumstances, Government are pleased to issue orders directing the Director of Panchayats to comply the order of the Hon'ble Tribunal.
