ORDER

As per the Order read above Hon'ble National Green Tribunal has directed to appoint a Joint Committee comprising of the following members to prepare an action plan with specific time line to abate the pollution in the Konothupuzha river, in Ernakulam District and submit the same before the Hon'ble Tribunal within a period of 3 months.

- iv. Secretary, District Panchayat, Ernakulam
- v. Commissioners of the respective Municipalities and Executive Officers of the respective Grama Panchayat
- vi. Secretary of the Municipalities and Grama Panchayats through which the river passes
- 2) In compliance with the Order of Hon'ble NGT read above Government are pleased to constitute a Joint Committee with the following members to prepare an action plan with specific time line to abate the pollution in the Konothupuzha river, in Ernakulam District.
