# **ORDER**

As per the G.O read as 2nd paper above, Administrative sanction was accorded for the Project "Rehabilitation of Thrissur Corporation Water Scheme to Koorkenchery Zone" for an amount of Rs 3.41 Lakh. The 24th SHPSC of AMRUT held on 27/05/2020 has decided to accord sanction for revision of Administrative Sanction for the Project "Rehabilitation of Thrissur Corporation Water Scheme to Koorkenchery Zone - supply & laying of separate branched gravity main of 400mm D1 K9 & replacement of 700mm Premo with 700mm DI K9 pipe and supply erection & commissioning of 65 HP centrifugal motor pump set for replacing of existing old pump sets - 2nos. at Koorkenchery sump - allied works" (SAAP 2015-16) being implemented by KWA in Thrissur Corporation for Rs. 3,71,31,035/-.

The reason for revision is due to the revision of road restoration charges by PWD.

- 3. The Mission Director has requested to accord revised Administrative sanction for the project "Rehabilitation of Thrissur Corporation Water Scheme to Koorkenchery Zone" for an amount of Rs 3,71,31,035/-.

Government have examined the matter based on the decision taken in the 24th SHPSC of AMRUT held on 27/05/2020 and are pleased to accord revised Administrative sanction for the project "Rehabilitation of Thrissur Corporation Water Scheme to Koorkenchery Zone" for Rs. 3,71,31,035, subject to the condition that the additional fund requirement of Rs.0.303 Cr. shall be met from the savings under Water Supply sector in Thrissur Corporation, for which AS has been accorded vide G.O read as 1st paper above.
