ORDER

Smt. Ujitha K.M has filed OA (EKM) No. 469/2020 before the Hon'ble Kerala Administrative Tribunal with a prayer to transfer her in convenient place in the native district, Thrissur.

- 2. By disposing the OA (EKM) No.469/2020 filed by Smt. Ujitha K.M, the Hon'ble Kerala Administrative Tribunal in its order read as 2nd paper above have directed the 1st respondent, the Government to take a decision on Annexure 4 after hearing the Applicant and respondents 4 and 5 as expeditiously as possible, at any rate within a period of two months from the date of production of a certified copy of this order, which will be produced by the Applicant along with a copy of Original Application.
- 3. The Applicant is promoted as Accountant and posted in Thiruvegappura Gramapanchayat in Palakkad District as per the proceedings read as 3rd paper above by retaining the 3rd and 4th Respondents, Sri. Santhosh .C.R and Sri.Sunil Kumar P.S, respectively, who are her juniors, as Accountants promotees and are posted in Thrissur District itself. The Applicant has filed representation before the 1st respondent, Secretary to Government. Simultaneously the Director of Panchayat has called for application for general transfer from among Accountants and the incumbent requested for

transfer to Sreenarayanapuram Gramapanchayat in Thrissur District. Accordingly the Applicant was transferred to her home district, Thrissur and was posted in Sreenarayanapuram Gramapanchayat as per the order read as 4th paper above. Accordingly the grievance of the applicant has been redressed.

- 4. In compliance of the direction of the Hon'ble Kerala Administrative Tribunal, the applicant was heard over phone on 04.09.2020. During the hearing the applicant has informed that she has been transferred in the general transfer and posted to the station opted, ie Sreenarayanapuram Gramapanchayat in Thrissur District and hence her grievance has been redressed.
- 5. The order of the Hon'ble Kerala Administrative Tribunal read as 2nd paper above is thus complied with, accordingly.
