ORDER

Sri. Joy John, retired Joint Director of Panchayat, has submitted an application to declare his period of probation in the cadre of Deputy Director of Panchayat as per 1st paper read above. Government examined the admissibility of the same. The Accountant General, Kerala vide letter read as 2nd paper above has informed that Sri.Joy John has not availed any kind of leave other than casual leave during the period from 6/7/2018 to 5/1/2019. The Vigilance Department vide U.O Note read as 3rd paper above has informed that no Vigilance case/ Vigilance Enquiry is pending against Sri.Joy John and further intimated that Vigilance Department had recommended to initiate departmental action against Sri.Joy John for the irregularities noted in the enquiry conducted by the vigilance Department in V.E No. 5/2018/TVM while the applicant was working as Secretary, Vilavoorkkal Grama Panchayat.

Government examined the matter and on verification of records, it is found that based on the recommendation of the Vigilance Department, disciplinary action had been initiated against the applicant herein. While pursuing action, the applicant filed O.A before the Hon'ble High Court of Kerala challenging the veracity of proceedings initiated against him. Later Government as per the direction of the Hon'ble High Court of Kerala in O.P (KAT) No. 48/2020, issued orders by exonerating the applicant from the charges levelled against him as per Government order read as 4th paper above.

In the circumstances Government are pleased to order that Sri. Joy John, retired Joint Director of Panchayats has satisfactorily completed the period of probation in the cadre of Deputy Director of Panchayats with effect from 06.01.2019 F.N.
