ORDER

Sri. Manojkumar K, Secretary, Maniyoor Grama Panchayat filed O.A(EKM) No. 1285/2020 before the Hon'ble Kerala Administrative Tribunal with a request for a transfer to his home station. As per the order read as 2nd above the Hon'ble Kerala Administrative Tribunal has directed Government to consider and pass appropriate orders on Annexure A10 in the light of the relevant Government orders including G.O.(P)No.3/2017/P&ARD dated 25.02.2017 and the provisions of the Right of persons with Disabilities Act, 2016, within a period of six weeks from the date of receipt of a certified copy of the order.

2. Government examined the matter in detail. The O.A. is filed aggrieved on the denial of transfer to the home station by the Grama Panchayat Secretary Sri. Manojkumar K. The transfer and posting of the Grama Panchayat Secretaries is vested in the delegation of powers of the the Director of Panchayats. Hence, the Director of Panchayats is directed to consider the Annexure A10 appeal in the light of the relevant Government orders including G.O.(P)No.3/2017/P&ARD dated 25.02.2017 and the provisions of the Right of persons with Disabilities Act, 2016. The details of action taken in this regard

should be communicated to the Hon'ble Administrative Tribunal and Government in due course.

3. The order of the Hon'ble Kerala Administrative Tribunal read 2nd paper above is thus complied with.
