As per the letter read as first paper above, the Secretary, Goshree Islands Development Authority, Ernakulam has requested for Administrative and Expenditure Sanction for an amount of Rs.4,31,00,00/-[Rs.3,50,00,00/-(estimate for the road work and Rs.81,00,000/-for land acquisition)] for the project, "Construction of approach road from Pizhala connectivity Bridge to Pizhala Road". As the estimate submitted was not in the PRICE Software, a revised estimate has been requested and as per letter read as second paper above, estimate in PRICE Software amounting to Rs.3,99,00,000/- submitted for the Construction of road from Pizhala connectivity bridge to Pizhala Road.

Government have examined the matter in detail and are pleased to accord Administrative and Expenditure Sanction for an amount of Rs.4,80,00,000/- (estimate cost of the work-Rs.3,99,00,000/- and cost of land acquisition-Rs.81,00,000/-) for the project "Construction of approach road from Pizhala connectivity Bridge to Pizhala Road" and also to entrust ULCCS as the accredited agency for implementing the scheme subject to the condition that the project cost should be met
