ORDER

The Central Government has announced the second phase of Swachh Bharat Mission (Gramin) in March 2020 with an emphasis to sustain the ODF status achieved by villages and to cover villages with proper Solid and Liquid Waste Management (SLWM) arrangement. It is intended to work towards ensuring that no one is left behind and that everyone has access to use a toilet.

3. As per the letter read as 1st paper above, Ministry of Jalshakthi, Department of Drinking Water and Sanitation has informed that Government of India have approved Phase II of Swachh Bharath Mission (Gramin) to be implemented from 2020-21 to 2024-25. Ministry of Jalshakthi, Department Drinking Water and Sanitation has also requested to prepare and submit the State Project Implementation Plan(PIP) and Annual Implementation Plan (AIP) for the year 2020-21. Accordingly State Suchitwa Mission has submitted the AIP for an amount of Rs.38568.07 lakh as Swachh Bharat Mission (Gramin) share to the Ministry of Jalshakthi, Department of Drinking Water and

Sanitation. As per the minutes read as 2nd paper above, National Scheme Sanctioning Committee (NSSC) of SBM(G) Phase-II has approved the Annual Implementation Plan for Kerala for the Financial Year 2020-21 as follows.
