**ORDER**

As part of development of Kadamakkudy Panchayat, Goshree Development Authority (GIDA) took up the widening of the existing Panchayat road to 9 m width and construction of two bridges, viz, Chennoor-Pizhala Bridge and Cheriyaamthuruthu-Chennoor Bridge in Vypin constituency in Ernakulam District.

2) The Secretary, Goshree Development Authority, as per letter read above, submitted a detailed estimate for the construction of Cheriyaamthuruthu-Chennoor Bridge in Vypin amounting to Rs.20,50,00,000/-(Rupees Twenty crore Fifty lakh only) and also requested sanction for execution of the work by entrusting PWD Bridges Division or Finance Department accredited agencies as implementing agency to fast track the projects.

3) Government have examined the matter in detail and are pleased to accord administrative and expenditure sanction for the construction of Cheriyaamthuruthu-Chennoor Bridge in Vypin Constituency for an estimated amount of Rs.20,50,00,000/-(Rupees Twenty crore and fifty lakh only) from own fund of GIDA subject to the condition that GIDA should have financial capacity to carry out the work and no fund shall be allotted from Government. Sanction is also accorded for entrusting PWD Bridges Division as implementing agency for procuring technical sanction and other necessary clearances to fast track the project.
