ORDER

As per the letter read 1st, 2nd and 4th paper above, Government of India sanctioned a total amount of Rs.4.20 Crore as Central Share of Administrative Fund for the Shyama Prasad Mukherji Rurban Mission, and the same was released by State Government vide Government Orders read as 3rd, 5th and 6th paper as detailed below;

2) As per the letter read as 7th paper above, Government of India has clarified that the approved Administrative Budget of the Scheme is to be shared between the Centre and State in the ratio of 60:40 and has directed the State to release the corresponding pending State share of Administrative Fund.

3) As per the letter read as 8th paper above, the Commissioner for Rural Development has requested to take necessary measures for sanctioning an amount of Rs.2.88 Crore towards the pending State share of the Administrative Fund of National Rurban Mission and authorizing the Commissioner for Rural Development to draw the amount and transfer credit to the PSTSB account of 799012700000267 at District Treasury, Thiruvananthapuram.

4) Government have examined the matter in detail, and are pleased to accord sanction for the release of an amount of **Rs.2,88,00,000/ (Rupees Two Crore and Eighty Eight Lakh only)** towards the pending State Share under the Head of Account 2515-00-102-35-NRM (P) from current year's budget provision.

5) The amount will be transfer credited to the PSTSB Account No.799012700000267 maintained at District Treasury, Thiruvananthapuram and the Commissioner for Rural Development is authorized to draw and disburse the same.
