<u>ORDER</u>

As per the letter read as 2nd paper above, the Mission Director, AMRUT has informed that the Government have sanctioned an amount of Rs.1,65,20,000/- as the Central Share of the 3rd installment for the components of Master Plan Formulation and Capacity Building for the implementation of AMRUT Sub Scheme Formulation of GIS Master Plan for AMRUT Cities.

- 2. In this, Rs. 1,09,40,000/- is sanctioned from the Head of Account 2217-05-191-48 (AMRUT Corporations) and Rs. 55,88,000-/ is from the Head of Account 2217-05-192-48 (AMRUT Municipalities). The amount sanctioned from the Head of Account 2217-05-192-48 (AMRUT Municipalities) exceeds Rs.8,000/-
- 3. Also as per the order read as 1st paper above, Government have changed the Heads of Account in the following manner:

Government have examined the matters in detail and are pleased to accord sanction to release a total amount of Rs.1,65,20,000/- (Rupees One Crore Sixty Five Lakh Twenty Thousand only) to AMRUT Mission towards the 3rd installment for the components of Master Plan Formulation and Capacity Building for the implementation of the AMRUT Sub Scheme Formulation of GIS based Master Plan for AMRUT cities as given below and to transfer credit the amount in the PSTSB account No. 363 maintained by Mission Director, AMRUT at Sub Treasury, Vellayambalam to PFMS account No.6424109855 in Indian Bank, Thycaud Branch.
